IMPORTANT:

- **Tuition is due on the first (1st) of each month.**
- There will be a **\$10.00 late fee** added to your account if the balance due is not received by the 5th of each month and an **additional \$10 late fee** on the 20th of the month.
- A 30 day written or verbal notice is required should you withdraw your child from Calera Dance Academy. Parents are responsible for tuition until the end of the 30 day period.
- Tuition has been tabulated for the number of classes offered for the year. Fees are due August through May and will not be prorated for holidays or weather days or short months. Absences due to illness can be made up by attending another class.
- In October 2011, classes will be charged a **\$75 costume fee (non-refundable). Classes having two costumes will be charged \$135.**
- In January 2012 a **\$75 recital fee (non-refundable)** will be charged to each account for the annual Spring Recital.
Each additional sibling will be \$37.50.
- Each student is required to sell one (1) ad for the recital program to either a business or a family member.
